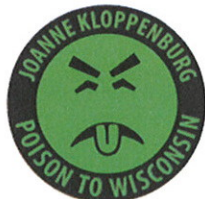

JOANNE KLOPPENBURG IS THE WRONG CHOICE FOR WISCONSIN FAMILIES

This upcoming election will determine which direction the Wisconsin Supreme Court will lean. Wisconsin home owners, sportsmen, land owners, and businesses should pay close attention and work hard to ensure Kloppenburg doesn't get elected. Joanne Kloppenburg:

Against Homeowners:

- Kloppenburg is the state's environmental law enforcer and represents the DNR in cases that target homeowners.
- Kloppenburg's position has been against local controls which favor the individual homeowner - opting for larger state controls over environmental issues.
- Legislators were needed to take action against what upset homeowners called DNR "arrogance" describing efforts lead by Joanne Kloppenburg.
- Kloppenburg described one court decision as "Wonderful" in which the court told a woman she couldn't build a deck on the back of her home.
- Kloppenburg's cases have even invoked letter writing to the governor. A Wisconsin couple wrote accusing the state of rendering their property worthless through bungling and zealotness. "It sure puts a sour note on our life" said one homeowner of Kloppenburg and the states action against him.
- An Ozaukee couple who owned two plots of land were told by the DNR that they couldn't build on one because it was considered a "wetland" after the couple had already gotten the necessary town and county approvals and a mortgage. After writing letters and eventually suing the DNR - Kloppenburg was the attorney who filed a motion in court to dismiss the couple's suit on behalf of the DNR.

Joanne Kloppenburg favors restrictions placed on individual landowners, homeowners and non-government entities. Kloppenburg has been at the center of opposing Wisconsin state legislative efforts to control and rein in the power of the DNR over environmental enforcement. Kloppenburg has supported the DNR's greater pursuit of power in court and been the one of their greatest allies. In many of those cases which reached all the way to the state Supreme Court. Kloppenburg directly conflicted with Justice David Prosser. Prosser argued for the DNR to have less power and the Legislature to have more in environmental issues between the state and individual homeowners.

David Prosser is a friend to homeowners and landowners, Joanne Kloppenburg believes the DNR should have absolute power over homeowners and their land.

Home Prosser vs Kloppenburg

PROSSER VS KLOPPENBURG

The differences are obvious, Justice Prosser has far more experience and integrity, impartiality, and competence and is the clear choice for Wisconsin Supreme Court Justice.

Justice Prosser

- Served 12 years on the bench as Wisconsin Supreme Court Justice
- Prior to serving for the supreme court Justice Prosser served 18 years in the legislator
- Served 2 years as Outagamie County District Attorney
- Served 2+ years in the United States Dept. of Justice
- In all these roles Justice Prosser has created, applied, and interpreted law and received high marks for his performance in every category.

Joanne Kloppenburg

- Assistant Attorney General Kloppenburg has been a litigator and prosecutor at the Wisconsin Dept. of Justice since 1989.
- 2009 - application for Wisconsin court of appeals (denied)
- 2009 - application for open federal judgeship (denied)
- 2004 - ran for Madison city attorney (not appointed)
- 2003 - Asked Gov. Doyle for appointment to seat on court of appeals (denied)

No judicial philosophy and no judicial record

Judicial Philosophy:

"I present myself as a judicial conservative, devoted to the constitution and the rule of law. My job is to find the law and apply it properly, not to make it up to advance some ideological objective."

Judicial Record:

In 12 years, Justice Prosser has participated in more than 900 published Supreme Court decisions and has written opinions in almost every area of law. His record for impartiality and scholarship is well known to people who closely follow the work of the court.
