approximately one week prior to the date of report. Stated that after that last e-mail, she received eight hang-up phone calls on her cell phone and stated the number was not blocked and came from Schmidt's home phone number of stated she did not hear anybody on the other end and no words were spoken between the two but she did get a little scared that Schmidt was becoming more angry with her for not contacting her and blocking her from My Space.

I did advise that she needed to discontinue all contact with Schmidt as well as she had informed me she continued to e-mail Schmidt when he e-mailed her having a general discussion. Stated she does not know what Schmidt looks like and is scared that he will become more angry, and she does not want to deal with him in person and is afraid that he may find out where she works and come down and visit her at her job. Stated she informed Schmidt she was going to call the police if he continued to contact her and stated he did e-mail her back after that regarding some of the phone calls. Then provided Schmidt's information out of the Isthmus newspaper and asked if I would call Schmidt to leave her alone. I did advise her I would call his home phone number and give him a warning to stop contacting her, and if he continued, she needed to report this back to the Police Department immediately. I then provided the with the case number and advised her on what to do if she started getting hang-up phone calls, e-mails, or random visits from Schmidt.

I then went into the CCB and left a message for Schmidt to stop all contact with which included e-mails, phone calls, texting, etc. At the end of my shift I had not heard back from Schmidt and returned to service on 3/27/07. I then received a phone call from Schmidt that he wanted to set up an appointment with me to meet with his lawyer. I advised Schmidt to come down to the CCB at his convenience with his lawyer, even though I did not need to speak to his lawyer due to no criminal charges being processed, and I would meet him.

and was informed that she was contacted by a female friend who stated they were an attorney for Schmidt and provided a State Bar code number so could verify she was an attorney. They female attorney left a message feet that they needed to discuss legal issues and wanted to call her back. I advised that she did not need to do this, and stated I was planning on meeting with Schmidt later in the afternoon. Schmidt then came down to the CCB with his attorney and stated he met through her My Space web page in January of 2007, but has not technically met her in person. Schmidt stated they were e-mailing back and forth in a friendly nature and then stated blocked him from her My Space account and sent him an email to leave her alone. Schmidt stated to me he did stop contact with her and stated he has not contacted her via phone until she accused him of hanging up on her. Schmidt stated he has all e-mail messages saved between the two of them, and stated did not ask him to stop contacting her until recently, and stated there was nothing in February that would state something similar. Schmidt also stated there was approximately 30 text messages back and forth that they were sending each other, and stated he thought this was a friendship. Schmidt stated on Friday of last week, which would be March 23, 2007, he heard from and was asking him if he was calling from blocked numbers. Schmidt stated he never called her with restricted phone numbers and stated he received another e-mail from was asking why he was calling her from his regular phone number and hanging up. Schmidt stated he was not calling those eight times and that he was at the mall purchasing items when his cell phone was bumping up against the counter and accidentally dialing because sphone number. Schmidt stated that because sphone is a PDA-type phone with no flip open front and somehow his phone accessed either the menu or the text message entry and then hit send when he was bumping on the counter, and he was not aware of any of this. Schmidt stated he will pull phone records if necessary, even though I told him there is no criminal prosecution going on right now, and this is just for documentation. I again advised Schmidt to not contact leaves even

if she continues to contact him, which I advised her not to. I advised Schmidt he could not e-mail her or any of her friends, and advised he could not have his friends contact her.
